They are: Credibility in Action, Focus Through Vision and Purpose, Manage Interdependencies: Work Beyond the Boundaries, Create a High Performance Work Environment and Do Skillful and Continual Diagnosis.

Whether it’s called the “silvering of society,” the “graying of America,” or “baby boomers aging up,” the numbers are unprecedented! Do courts recognize the impact this demographic change will have on their daily processes, case management and dockets? Are they prepared? Recently, courts across the country have received media attention highlighting court struggles to address these very issues. In 2005, the National Center for State Courts (NCSC) created the multidisciplinary Elder Abuse and the Courts Working Group (EACWG) to increase judicial and court awareness, build court capacity and develop tools courts can use to improve the identification of and response to the growing problem of elder abuse, neglect and exploitation. The Working Group met in April 2006; these national experts developed five core recommendations for courts. At the TOP was the need for strengthened judicial and court leadership in this area. They also identified the top key components of an effective court response and strategies to improve community coordination. Part 2 - Interpreter training? Why do I care about interpreter training? This is Part 2 of a three-part program for court managers who deal with a lack of resources (among them qualified interpreters) every day. Learn why interpreter training (IT) benefits you as a manager whether your court is metro or rural. This session is designed to help court managers understand why ongoing interpreter training (IT) is necessary and to better determine what level of skill is required to be considered a qualified interpreter. The numerous training approaches, the variety of available

curricula, the lack of enforceability in existing governmental regulations, and the lack of training requirements demonstrate the need for a standardized, comprehensive training curriculum for court interpreters. Part 3 – By Jove, I think we've got it! *Bringing it all together – Part 3 of this three-part program looks at Public Service Interpreting Resource Centers (PSIRC's). Learn how courts –large and small – can play a leadership role in better managing scarce interpreting resources, improve access to justice, and provide equal treatment to limited-English proficient (LEP) individuals. **The Solution: Resource and Service Sharing.** A cost efficient and effective way to help the American justice system meet its language needs is through a resource sharing program similar to the currently existing Consortium for State Court Interpreter Certification's testing program. That program allows a number of states to pool their resources and come up with cost efficient ways of managing their needs. PSIRCs can provide a cost effective and efficient way to meet the needs of multiple public service agencies.
