Chaired by Chief Justice Ronald M. George, the Judicial Council of California provides policy direction to the courts and advises the Governor and the Legislature on court practice, procedure, and administration. The council performs its constitutional and other functions with the support of its staff agency, the Administrative Office of the Courts (AOC). The AOC offers a full range of administrative support to California's judicial branch which comprises the state appellate and trial courts, the Habeas Corpus Resource Center, and the Judicial Council. This support includes legal research and advice; court project development and implementation; legislative analysis and advocacy; judicial and staff education; human resources services; information systems development; facilities operations; and accounting, business services, and budget advocacy, development, and management.

The branch, comprising about 3,500 employees, also is responsible for providing community supervision for more than 41,000 adult and juvenile offenders ordered to probation.
