Updates:

Tina Mattison

- An e-mail to all California NACM members resulted in two responses. Although California was targeted, we want to target Florida, Texas and New York as well. Tina talked with the Past Presidents who volunteered to assist in reaching out to purged members. Another thought would be to find ways to share information with Federal Courts, as well as partner with NAPCO.
- Michelle Oken shared that Los Angeles Superior Court does not pay membership dues, but will pay for managers to attend conferences

only, so it is difficult to keep memberships renewed.
