e. Creation of a WG to review CORE® Champion videos to see if they are still relevant/current – Brandon Kimura

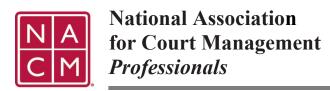
The working group has finished their work and recommended the following:

- 1. All videos on the attached list be retained for possible credit for the CORE® Champion program except one. That exception, #20 on the attached list, focused on COVID-19 issues in a coffee talk style to engage the audience. While we believe it accomplished its purpose well, it did not rely heavily upon the NACM Model Code nor reference the NACM CORE®.
- 2. Going forward, sessions selected to be recorded consider gaps in curricula. While there is at least one recording for each curricula, there are several with only one.
- 3. A note be appended to both videos #6 and #28 because they are similar. We thoroughly discussed whether to recommend both be retained and we concluded that they should both be retained with a note. Here is a note for consideration: This recorded session, entitled CORE Leadership Webinar, is similar to the session entitled The Leadership Competency—Being a Resilient Leader.
