 accessed by the full board, such as CORE presentations, strategic planning work, etc. A lot of these

- **NEW**: Roger noted that the "Question of Ethics" page is not being updated correctly. There have been some that have been completed that haven't been posted. Dawn and Jeffrey will follow-up.
