



National Association for Court Management and National Council of Juvenile and Family Court Judges Partnership Agreement for Dual Membership Discount

To assist court managers with their professional development and provide added value to current and future members of the National Association for Court Management (NACM) and the National Council of Juvenile and Family Court Judges (NCJFCJ), the respective Boards of Directors of each association have agreed to the membership discounts outlined below. Members joining or renewing with both associations will receive a dues discount.

Individuals who are members of the NCJFCJ qualify for a 20% discounted NACM regular member membership rate. In turn, individuals who are members of NACM qualify for a 17.25% discounted NCJFCJ associate membership rate.

The total amount of the discount for dual membership will be \$50 per member, per year, shared by the NCJFCJ and NACM as follows:

- o NACM agrees to a \$25 (20%) discount for NCJFCJ members who join NACM.
- NCJFCJ agrees to a \$25 (17.25%) discount for NACM members who join the NCJFCJ as an Associate Member. The NCJFCJ discount does not apply to memberships for judicial officers.

As part of the Partnership Agreement, the NCJFCJ and NACM agree to advertise the dual membership discount to their members.

Current members:

- Current NCJFCJ members wishing to take advantage of the dual membership discount with NACM shall attach a copy of their current year NCJFCJ dues receipt to their NACM invoice or application to receive the reduced NACM rate.
- Current NACM members wishing to take advantage of the dual membership discount with the NCJFCJ shall attach a copy of their NACM receipt to their NCJFCJ invoice or application to receive the reduced NCJFCJ associate membership rate.

New members:

 Individuals who are neither NCJFCJ nor NACM members shall first join the NCJFCJ noting their intent to join NACM. The reduced NCJFCJ rate will be honored and a receipt provided to attach to the NACM application to receive the NACM reduced membership rate.

As part of the Partnership Agreement, the NCJFCJ will receive the following additional benefits from NACM:

- o Complimentary listing as a Partner Association on the NACM website
- Access to the NACM membership database
 - Requests can be made twice a year
 - Send an email to nacm@ncsc.org
 - Indicate that the NCJFCJ has a dual membership agreement with NACM
 - Include purpose for which the NCJFCJ would like to access NACM membership
 - NACM may determine whether to provide email addresses to the NCJFCJ for the approved purpose, or whether the NACM will forward the intended message to NACM members on the NCJFCJ's behalf. If emails are provided, email addresses are for a one-time use only and cannot be used for multiple emails
- Complimentary distribution area at NACM annual conference for NCJFCJ marketing materials

As part of the Partnership Agreement, NACM will receive the following additional benefits from the NCJFCJ:

- o Complimentary listing as a Partner Association on the NCJFCJ website
- Access to the NCJFCJ membership database
 - Requests can be made twice a year
 - Send an email to sgrabowska@ncjfcj.org
 - Indicate that NACM has a dual membership agreement with NCJFCJ
 - Include purpose for which NACM would like to access the NCJFCJ membership
 - The NCJFCJ may determine whether to provide email addresses to NACM for the approved purpose, or whether NCJFCJ will forward the intended message to NCJFCJ members on NACM's behalf. If emails are provided, email addresses are for a one-time use only and cannot be used for multiple emails
- Complimentary distribution area at NCJFCJ Annual conference for NACM marketing materials

This Agreement will be in effect for two years from the date of the last signature and may be renewed at the end of that period. The Agreement may be rescinded by NACM or the NCJFCJ upon 60 days written notice to the other party.
