NATURAL FATHER'S VOLUNTARY CONSENT TO TITLE 25 THIRD PARTY LEGAL DECISION-MAKING AUTHORITY AND FOR PLACEMENT OF A CHILD PURSUANT TO A.R.S. § 25-409 AND THE INDIAN CHILD WELFARE ACT, AND CERTIFICATION

I.

My name is XXXXXXX, and I am the father of XXXXXXX, who was born on March 7, 2016. I speak, read, and write the English language. II.

I am entering into this consent of my own free will and I have not been threatened or forced in any way to consent to delegating third party legal decision making authority and for placement of my child XXXXXXXX with their maternal grandmother, XXXXXX. I am signing this consent freely and voluntarily and not as a result of any fraud, duress or undue influence. The terms, conditions, and consequences of this consent have been explained to me.

III.

I understand the following consequences of my consent to delegating third party legal decision making authority and for placement of my child with XXXXXXXXX:

- 1. I will no longer have the legal right to make decisions for the care, education, custody or control of XXXXXXX until further order of the court.
- 2. I will no longer have the legal right to receive monies payable for the support of XXXXXXXXX under the terms of any statutory benefit, insurance, private contract, devise, trust, conservatorship or custodianship.

1	3. I will only be allowed to visit XXXXXXXXXX with the prior approval of his
2	maternal grandmother and/or pursuant to the Memorandum of Understanding
3	re: Parenting Plan Agreement the Court as adopted as an order in this case.
4	IV.
5	I understand my rights to withdraw my consent, under the Indian Child Welfare Act, 25
	U.S.C. § 1913(b), to the delegation of third party rights of XXXXXXXXX to the maternal
6	grandmother, and I intend to waive my rights as follows:
7	1. I intend to waive my right to withdraw my consent to delegating third party
8	rights until further order of this court, by signing this consent.
9	2. I do not intend to waive any of my other rights under the Indian Child Welfare
10	Act by signing this consent, aside from the right to withdraw my consent to
11	delegate third party rights under § 1913(b) as described above.

	I understand that according to A.R.S. § 25, if there is a significant change of circumstances
13	after a final decree and delegation of third party rights, I have a right to file a petition for
14	modification of the delegation of third party rights.
15	VI.
16	Consistent with the terms and conditions above, I hereby consent to the following:
17	1. Third party rights for XXXXXXXXX will be delegated to his maternal
18	grandmother, XXXXXXXX. 2. XXXXXXX will have legal and physical custody of XXXXXXXX until a court of
19	competent jurisdiction determines otherwise.
