https://mycase.in.gov is Indiana's free public access website for real-time court case information. Members of the public can access non-confidential cases and documents from across the state courts and appellate courts, searching by case number, party name, or attorney. Attorneys can sign in for enhanced access, including access to their own confidential cases and documents. This access is provided at no charge to users.

The Indiana Supreme Court Trial Court Technology division developed this custom application in house, connecting it to data from the Odyssey case management system by Tyler Technologies. More than 70% of the state's cases are currently available; additional courts are added each year as more counties adopt our statewide system. MyCase is a work in progress, and new access and features are added regularly. From 4/1/17 to 3/31/18, the site had over 26 million page views by 7.7 million users.

Though not by design, paper court records of the past struck a pragmatic balance between public access and litigant privacy. Non-confidential records were freely available to the public, but visiting the courthouse where the physical file was located involved enough inconvenience that most case information effectively remained private. In other words, these public documents were kept in "practical obscurity."

Online chronological case summaries are now nearly universal, allowing easy remote access to at least basic case information. MyCase provides the public with free, easy access to public court information and documents. No login required. No subscription. No fees.

Best Practices / Sound Business Practices

The MyCase website is a model for public access to court information. The site was built with users in mind: it's fast, device agnostic, and easy-to-use. Security and performance are the top priorities when any change to the application is made.

Further, decisions about which cases and documents to include and exclude from public access and the enhanced access for attorneys are made by the Supreme Court based on recommendations from a multi-disciplinary Task Force. With over forty different case types used in Indiana to designate a myriad of substantive proceedings, and thousands of combinations of particular pleadings, motions, and orders that may be filed or entered in those proceedings, it is a prodigious undertaking—but one the Task Force is approaching methodically and thoughtfully to seek the best possible balance between transparency and privacy.


