Proposed fee structure:

Increase the spread between the member and non-member registration fee to be greater than the cost of registration. Propose changing non-member fee from \$710.00 to \$750.00.

Allow Simultaneous Membership Application and Conference Registration under Current Fee Structure

We do not currently offer a one-year membership with registration but if individuals join as a member and then register for the conference, they pay the same fee that a non-member would pay to register (\$585 + \$125). If we choose not to modify the registration fee as described above, it would behoove NACM to allow simultaneous membership application and conference registration because by “giving” conference registrants a one-year membership, we increase potential for those individuals to renew membership having experienced all that NACM has to offer.

- consider raising the "sustaining" membership fee. “Companies are always willing to pay for mailing lists, so with this being included in the membership, I think it should go up to around \$500 from \$350
