## INTERNATIONAL COURT CONSULTING OVERVIEW

Numerous court improvement projects are in progress around the world. Behind this activity is the realization that sustainable economic development depends in some measure on a stable, reliable court system and the call for improved standards of human rights where they have not been a priority in the past.

The United States and other countries are engaged in consulting and education efforts that are helping many courts to improve. This includes work on the rule of law, democratic principles, and the role of courts. Several entities, including the USAID and the World Bank provide major funding for the projects. Many consulting groups are continuously looking for experienced court personnel with various areas of expertise for both short (1-2 weeks) and long term (up to three years) assignments.

It is intended that the International Committee work will be a valuable contact point and resource for other countries and project leaders seeking contacts and administrators to provide specialized technical assistance.
