Dual Membership Discount

To assist court managers with their professional development and provide added value to current and future members of the National Association for Court Management (NACM) and the **Pennsylvania Association of Court Management (PACM)** the respective Boards of Directors of each association have agreed to the membership discounts outlined below. Members joining or renewing with both associations will receive a dues discount.

Individuals who are members of the **PACM** qualify for the discounted NACM regular membership rate. In turn, individuals who are members of NACM qualify for a discounted **PACM** regular membership rate.

The total amount of the discount for dual membership will be **\$52.50** per member, per year, shared by the **PACM** and **NACM** as follows:

- NACM agrees to a **\$22.50** discount for **PACM** members who join NACM.
- **PACM** agrees to a **\$30.00** discount for NACM members who join **PACM** as a Regular Member

OR

- **PACM** agrees to a **\$7.50** discount for NACM members who join **PACM** as an Associate Member

As part of the Partnership Agreement, **PACM** and **NACM** agree to advertise the dual membership discount to their members.

Current members:

- Current **PACM** members wishing to take advantage of the dual membership discount with NACM shall attach a copy of their current year **PACM** dues receipt to their NACM invoice or application to receive the reduced NACM rate.
- Current NACM members wishing to take advantage of the dual membership discount with the **PACM** shall attach a copy of their NACM receipt to their **PACM** invoice or application to receive the reduced **PACM** rate.

New members:

- Individuals who are neither **PACM** nor NACM members may first **PACM** noting their intent to join NACM. The reduced **PACM** rate will be honored, and a receipt provided to attach to the NACM application to receive the NACM reduced membership rate.

As part of the Partnership Agreement, the **PACM** will receive the following additional benefits from NACM:

- Complimentary listing as a Partner Association on the NACM website.
- Access to the NACM membership database for the **PACM**
 - Requests can be made twice a year
 - Send an email to nacm@ncsc.org
 - Indicate that the **PACM** has a dual membership agreement with NACM
 - Include purpose for which the **PACM** would like to access NACM membership
 - NACM may determine whether to provide email addresses to the **PACM** for the approved purpose, or whether the NACM will forward the intended message to NACM members on the **PACM** behalf. If emails are provided, email addresses are for a one-time use only and cannot be used for multiple emails
- Complimentary distribution area at NACM annual conference for **PACM** marketing materials

As part of the Partnership Agreement, NACM will receive the following additional benefits from the **PACM**:

- Complimentary listing as a Partner Association on **PACM** website.
- Access to the **PACM** membership database
 - Requests can be made twice a year
 - Send an email to: <https://pacm.wildapricot.org/Contact>
 - Indicate that NACM has a dual membership agreement with **PACM**
 - Include purpose for which NACM would like to access the **PACM** membership
 - **PACM** may determine whether to provide email addresses to NACM for the approved purpose, or whether **PACM** will forward the intended message to **PACM** membership on NACM's behalf. If emails are provided, email addresses are for a one-time use only and cannot be used for multiple emails
- Complimentary distribution area at **PACM** conferences for NACM marketing materials

This Agreement will be in effect for two years from the date of the last signature and may be renewed at the end of that period. The Agreement may be rescinded by **NACM** or the **PACM** upon 60 days written notice to the other party.
